

PATNA UNIVERSITY

Proposed Amended Ordinance for Admission of Students to Post Graduate Degree Course in Biochemistry (Semester System).

1. Admission to M.Sc. Biochemistry course (Semester System) is open to candidates who have passed B.Sc. (Hons.) or M.B.B.S. examination or equivalent conducted by a University established or incorporated by law and are eligible to apply for admission.
2. Admission to the Post Graduate Course in Biochemistry shall be made on the basis of the marks obtained at the Aptitude/Entrance Test conducted by the Department.
3. Number of seats of the course shall be 32.
4. The reservation of seats for the course shall be as per rules of the Patna University.
5. The fee structure of the course per semester applicable from session 2012 will be as follows:

The full course fee shall be payable at the time of admission in each semester.

7. Every candidate shall have to pay Rs.500/-only (Rupees Five hundred only) as examination fee payable every year.
8. The fee structures may be reviewed every three years by the Vice-Chancellor in consultation with the Head of the Department.
9. The Post Graduate Degree in Biochemistry Course shall be place in the Faculty of Science.
