

**Proceedings of the meeting of Controller of Examination held on
07.09.2018 at 11.30 A.M. under the Chairmanship of Principal
Secretary, Governor's Secretariat, Bihar, Patna.**

Present - As per Annexure

1. Principal Secretary to Hon'ble Chancellor Shri Vivek Kumar Singh welcomed all the participants and stressed that the primary function of University is timely conduct of examination, timely publication of results and timely distribution of degrees for Under Graduate Courses by Vice Chancellors and for Post Graduate Courses by Hon'ble Chancellor, in the convocation ceremony.
2. Timely distribution of degrees requires that examination at Under Graduate and Post Graduate level are conducted by strictly adhering to academic and examination calendar.
3. The status of conduct of examinations by different universities are as follow :-

Name of Universities	Status of conduct of Examination
Jai Prakash University, Chapra	➤ Examination of 2014-2017 session of Under Graduate Part-II and examination of 2015-18 session of Under Graduate Part-I were conducted in July 2018, result has not yet been published.
Bhupendra Narayan Mandal University, Madhepura	➤ The Controller of examination assured to conduct all pending examination of Under Graduate Courses by December, 2018 ➤ For Post Graduate Courses, he had informed that the examination have been rescheduled from 15 January, 2019 because admit cards could not be distributed on time, to students.

<p>Magadh University, Bodhgaya</p>	<ul style="list-style-type: none">➤ Controller of examination had informed that due to non availability of answer books on time, examination could not be held as scheduled. He had informed that answer books were purchased through GeM and only on 06.09.2018, answer books were supplied.➤ Controller of examination was cautioned to adequately plan in advance to conduct examination in future. Shortage of answer books should have been visualized/assessed by University before declaring the programme of examinations.➤ In the meeting of Pro-Vice-Chancellors, it was instructed that the Pro-Vice-Chancellor of Magadh University, Bodh Gaya and Pro-Vice-Chancellor of Bhupendra Naryan Mandal University, Madhepura & Pro-Vice-Chancellor, TMBU, Bhagalpur should submit status of examination schedule and the reason for not conducting examinations as per the schedule, submitted by University through their Controller of Examination. Controller of Examination of these Universities failed to submit the reasons for not conducting the examination on time.➤ Controller of examination Magadh University, Bodh Gaya was directed to submit date wise report about conduct of examination and proposed date for publication of result.
<p>Veer Kunwar Singh University, Ara</p>	<ul style="list-style-type: none">➤ Controller of examination Veer Kunwar Singh University, Ara informed that due to correction in the pending result of 6000 students, the examination calendar, submitted earlier, could not be adhered to.➤ For degree part-1 Under Graduate examination of 2017-20 session the date has been rescheduled due to strike, of non teaching employees.

Tilka Manjhi Bhagalpur University, Bhagalpur	➤ Controller of Examination, TMBU informed in the meeting that the delay in payment to Agency which supplies stationery required to conduct the examination, was the main reason for rescheduling the examination. He informed that the examination of Under Graduate courses schedule from 08.09.2018 would be started from 20.09.2018.

4. Controller of examination of Bhim Rao Ambedkar University, Muzaffarpur and Kameshwar Singh Dharbhanga Sanskrit University, Darbhanga have informed that the University would conduct the examination on time.

5. There was no issue of delay in the conduct of examination of Patna University, Patna, Maulana Mazharul Haque Arabic & Persian University, Patna and Nalanda Open University, Patna and all the three newly constituted universities, namely Patliputra University, Patna, Munger University, Munger, Purnea University, Purnea.

6. All the universities were directed to strictly adhere to the academic and examination calendar submitted by them.

7. They were told that, in future, no rescheduling of the examinations and publication of the results would be permitted without the prior approval of Hon'ble Chancellor.

8. Strong displeasure was shown about the performance of BNMU, Madhepura, MU, Bodh Gaya, TMBU, Bhagalpur and VKSU, Ara. They were reminded to be extremely cautious in submitting the examination schedule. Responsibility would be fixed for not following academic and examination calendar.

9. The meeting ended with a vote of thanks.
