Sub:- Approval of the Regulations for conducting Special Examination of three years Degree (Conventional and Vocational) Part I and Part II for the examinees who have passed Degree Part III Examination during 2009-2010 to 2013 session of Baba Saheb Bhimrao Ambedkar Bihar University, Muzaffarpur.

Sir,

I am directed to invite a reference to University's letter No.69/VC, dated 21.06.2014, letter no. B/1664, dated 23.07.2014, letter no. 93/VC, dated 26.07.2014, 444/R, dated 28.07.2014, letter no. B/1804, dated 12.08.2014 and your letter no. 73/VC, dated 23.06.2014, on the subject noted above and to inform that Hon'ble Chancellor, after due consideration of the proposal of the University, advice of the Advisory Committee and in exercise of powers vested in him under Section 39(2)(ii-proviso) of Bihar State Universities Act, 1976, as amended up-to-date, has been pleased to approve the following two special Regulations.

(i) *"Notwithstanding provisions contained in para 7.1 of the regulation for three year degree course examination Special examinations for TDC Part-I & Part-II for the examinees during 2009-13(Conventional) who had not cleared their TDC Part-I & Part-II examinations although they had appeared in TDC Part-III examination be held subject to the condition that this benefit be limited to examinees as referred above and in no case this be cited as an example in future."*

(ii) *"Notwithstanding anything in para 3(I) of the Regulation as approved by the Chancellors office vide letter no. BU-69/1997-2140/GS(I), dated 23.07.1998, special examination for Vocational Course in the following subjects:-*

- (i) B.Sc./B.Com/B.A. Vocational Hons. in Bachelor in Computer Application.
- (ii) B.Sc. Vocational Hons. in Clinical Nutrition and Dietetics.
- (iii) B.Sc. Vocational Hons. in Industrial Microbiology.
- (iv) B.Sc. Vocational Hons. in Biotechnology.
- (v) B.Sc. Vocational Hons. in Industrial Chemistry.
- (vi) B.Sc. Vocational Hons. in Industrial Fish & Fisheries.
- (vii) B.Com/B.A. Vocational Hons. in Advertisement Sales Promotion and Sales Management.

for the students of Vocational Part-I and Vocational Part-II session 2009-2012, 2010-2013 may be permitted to B.R.A. Bihar University. However this permission is one time and will die with the conduct of examination. It will not be a precedent and can not be cited for other such situations”.

2. The Hon'ble Chancellor has also been pleased to direct to seek explanation from the concerned authorities and initiate suitable punitive/legal action within a definite time frame under intimation to Chancellor's Secretariat.

The Hon'ble Chancellor has further been pleased to direct that in order to clear the ambiguities, submit separate Ordinance and Regulations for each courses to avoid any ambiguity in future, otherwise these courses must be stopped with immediate effect.

Further necessary action may kindly be taken accordingly.
