Sir,

I am directed to invite a reference to your letter No. 261/RAU(VC) dated 21/05/2012 and No. 510/RAU(VC) dated 25/09/2012 on the subject noted above and to say that the Hon'ble Chancellor, after due consideration, has been pleased to approve the following Terms & Conditions of your appointment to the post of Vice-Chancellor, Rajendra Agriculture University, Pusa :-

1. Pay of Rs. 75,000/- fixed + Rs. 5000/- as Special Pay per month.
2. Rent free & furnished residence and no charge to fall on Vice Chancellor in respect of maintenance of such residence.
3. Provident fund/Retirement benefits to be governed by rules prescribed by the State Govt./Central Govt. in this respect.
4. Dearness Allowance as admissible by the State Govt. to the equivalent category of All India Officers.
5. Free electricity and water.
6. Official vehicle for him & his wife throughout his terms of office.
7. Sumptuary Allowance of Rs. 2000/- per month.
8. C.L. and other leave in accordance with the provisions of Bihar Service Code to be sanctioned by the Hon'ble Chancellor.
9. Traveling and other allowances as per the rate fixed from time to time by the Government of India.

10. Medical reimbursement in case of medicines purchased from the market on the prescription of authorized Medical Attendant of University/Government hospital.
11. Transfer Traveling Allowance & other allowances as admissible to the officers of the rank of Secretary to Govt. of India for joining and relinquishing the post.
12. L.T.C. and Home Travel Concession as per rules of the Government of India.

Further action may kindly be taken accordingly.

STANDING ORDER

## Sub.: Pay and allowances of Vice Chancellors.

In supersession of previous orders determining terms & conditions of Vice Chancellors relating to pay and allowances, the Chancellor, after due consideration, has been pleased to approve the following pay and allowances:

- (1) Pay Rs. 7600/- per month.
- (2) Provision of a free-furnished residence commensurate with the status of the incumbent. However, if the Vice Chancellor chooses to reside in his own house, he may be allowed 20% of his pay as allowance in lieu of a free-furnished residence.
- (3) Provident Fund contribution by the University on the basis of Rs. 7600/- per month.
- (4) D.A. as admissible by the State Government to the equivalent category of All India Officers.
- (5) Free electricity and water.
- (6) Free staff car facility with free fuel and driver.
- (7) Sumptuary allowance of Rs. 500/- per month.
- (8) Leave including half pay leave and C.L. as admissible to employees of the University.
- (9) T.A. as admissible to the employees of the University.
- (10) Medical reimbursement will be admissible in case of medicines purchased from the market on the prescription of authorized medical attendant of Government hospital.
- (11) The Vice Chancellor will have to seek permission of Hon'ble Chancellor for going outside his jurisdiction.

The above terms and conditions relating to pay and allowances will apply in case of all existing Vice Chancellors and also to those who will be appointed as Vice Chancellor in the Universities of Bihar.
