NOTIFICATION

No. PU-26/2015-1147/GS(1) - (1) Vide this Secretariat's Notification No. PU-26/2015-968/GS(1), dated 24.05.2016 a committee was constituted to examine all major decisions taken by the Vice Chancellors, who were appointed in April, 2013 or thereafter as stop gap arrangement, in different Universities of Bihar except L.N. Mithila University, Darbhanga involving policy and/or with financial implications including appointments and promotions, to examine and see whether the decisions are in accordance with provisions of the Bihar State Universities Act, 1976, Patna University Act, 1976 and Statutes. This was constituted in compliance of the order dated 30.11.2015 passed by the Hon'ble High Court, Patna in C.W.J.C. No. 18733 of 2013 (Dr. Samir Kumar Sharma vs. The State of Bihar and others). The Committee constituted by Notification No. PU-26/2015-968/GS(1), dated 24.05.2016 could not be convened due to unavailability of members, necessitating its supersession and reconstitutions of a new Committee.

(2) In compliance of the Hon'ble Court's direction, advertisements were already issued in local newspapers inviting applications, objections from the public. All the Registrars of all Universities of Bihar, except L.N. Mithila University, Darbhanga were also directed vide letter No. PU-26/2015-609/GS(1), dated 21.03.2016 to submit complete list of major decisions taken by such Vice Chancellor along with concerned files and records to the Governor's Secretariat.

(3) The Hon'ble Chancellor after due consideration of all the facts and in exercise of the powers conferred upon him under Section 9(2) of the Bihar State Universities Act, 1976 and 10(2) of the Patna University Act, 1976, as amended upto date, has been pleased to reconstitute the committee after superseding the earlier Notification dated 24.05.2016. The committee shall comprise of the following:-
