Sub.-: Regarding strict compliance of mandate of Hon'ble High Court, Patna with respect to grant of affiliation to the Institution by the University and also upload the same on the website of the respective University as per approved schedule communicated vide Chancellor's Secretariat letter No.- Univ.(Misc)-04/2018-1179 /GS(I) dated-25-04-2018.

Sir,

I am directed to invite a reference to this Secretariat's letter No.- Univ.(Misc)-04/2018-1179 /GS(I) dated-25-04-2018, letter No. 2684/GS(I) dated 26-10-2018 and letter No. 2820/GS(I) dated-06-11-2018 on the subject noted above and to say that information of the list of Institutions, recommended by Affiliation Committee of the University till 15-10-2018 has not been uploaded by various Universities within the stipulated time, i.e., 05-11-2018, which is a matter of serious concern and violation of the mandate of the Hon'ble High Court. The Hon'ble Chancellor has taken this matter very seriously.

The Hon'ble High Court, Patna on 26-04-2018 in CWJC No. 4660/2017 has also directed that all concerned shall strictly follow not only the time schedule but also the provisions contained in the Statutes. The Hon'ble High Court on 17-09-2018 in the same matter has also required affidavit to be filed by the office of the Chancellor stating the follow up action in terms of the previous order in respect of completion of the process of disposal of applications for grant of affiliation and approval of affiliation by the State Government, if required.

You are therefore, requested to not to entertain any application for affiliation after the cut-off date of 15th September. Therefore, you are requested to expedite the same within a week without fail from the date of receipt of this letter for information and kind perusal of the Hon'ble Chancellor.

This may be treated as most urgent and given top priority.
