ORAL ORDER

An affidavit has been filed on behalf of the Chancellor's office in compliance of this Court's order dated 17.09.2018, a reading of which gives an impression to the Court that effective measures have been taken to ensure strict compliance of this Court's order 26.04.2018, passed in this case.

In view of the averments made in the counter affidavit, no further order need to be passed in the present proceeding.

I, however, observe that all of the functionaries must ensure strict compliance of the order dated 26.04.2018 passed in this case. The Court will take a serious note of the matter, if non-compliance of the said order is noticed. In such circumstance, the persons responsible may be liable for contempt of Court.

Let this order be communicated to the Vice-Chancellors and Registrars of all the Universities in the State of Bihar through the Office of the Chancellor forthwith.

The State of Bihar is being represented by learned GA-12. She shall ensure that this order is communicated to the Principal Secretary, Education Department, Government of Bihar, Patna.
